SECTION 4 - FIRST AID MEASURES

FIRST AID PROCEDURES:

Eye Contact: Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.

Skin Contact: In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention if redness or irritation develops.

Inhalation: Move exposed person to fresh air. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Get medical attention immediately.

Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Rinse mouth with water. Seek medical attention if symptoms appear.

SECTION 5 - FIRE FIGHTING MEASURES

Suitable Extinguishing media: Use an extinguishing agent suitable for the surrounding fire.

Hazardous combustion products: Oxides of carbon and various hydrocarbons

Fire Fighting Procedures: As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear. Apply alcohol-type or all purpose-type foams by manufacturers' recommended techniques for large fires. Use carbon dioxide or dry chemical media for small fires. Do not direct a solid stream of water or foam into hot burning pools; this may cause frothing and increase fire intensity.

Unusual Fire and Explosion Hazards Emits toxic fumes under fire conditions. Product floats on water creating a potential floating fire hazard.

SECTION 6 - ACCIDENTAL RELEASE and DISPOSAL MEASURES

Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid breathing vapor or mist. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment

Stop leak if without risk. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations.

SECTION 7 - STORAGE AND HANDLING

Handling: Do not get in eyes, on skin or on clothing. Do not ingest. Avoid breathing vapor or mist. Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use.

Storage: Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.

Engineering Controls: Provide adequate ventilation or other engineering controls to keep the airborne concentrations of dust or aerosols below the applicable workplace exposure limits indicated below.
