## SECTION 4 - FIRST AID MEASURES

**Eyes:** Immediately flush eyes with plenty of water. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.

**Skin:** Flush contaminated skin with plenty of water. Get medical attention if symptoms occur.

**Inhalation:** Move exposed person to fresh air. If not breathing provide artificial respiration. Get medical attention if symptoms occur.

**Ingestion:** Wash out mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Get medical attention.

## SECTION 5 - FIRE FIGHTING MEASURES

**Extinguishing Media:** To extinguish flames use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

**Fire Fighting Procedures:** Cool exposed containers with water spray. Wear self-contained breathing apparatus (SCBA) operated in pressure demand mode and full bunker firefighter's protective clothing.

**Fire and Explosion Hazards:** Containers can rupture and explode under fire conditions due to pressure and vapor buildup.

## SECTION 6 - ACCIDENTAL RELEASE and DISPOSAL MEASURES

Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas.

Stop leak if without risk. Prevent entry into sewers or ground water. Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container for disposal according to local regulations

## SECTION 7 - STORAGE AND HANDLING

**Handling and Storage:** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapor or mist.

**Other Precautions:** Keep in the original container, kept tightly closed when not in use

## SECTION 8 - EXPOSURE CONTROLS AND PERSONAL PROTECTION

**Engineering Controls:** Provide ventilation or other engineering controls to keep the airborne concentrations of vapor or mists below the applicable workplace exposure limits indicated below. The level of protection and types of controls will vary depending upon potential exposure conditions.

**Exposure Limits:** Ethylene glycol monopropyl ether Contains no substances with occupational exposure limit values.

### Personal Protective Equipment (PPE):

**Eyes** Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists or dusts.

**Skin:** If Personal protective equipment for the body should be selected based on the task being performed and the risks involved and should be approved by a specialist before handling this product.
