SECTION 4 - FIRST AID MEASURES

FIRST AID PROCEDURES:

Eye Contact: Flush eyes with plenty of water for at least 15 minutes. Seek medical attention.

Skin Contact: Wash with soap and water. Seek medical attention if irritation develops and persists.

Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. Seek medical attention if symptoms appear and persist.

Ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Rinse mouth with water. Seek medical attention if symptoms appear.

SECTION 5 - FIRE FIGHTING MEASURES

Suitable Extinguishing media: Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

Hazardous combustion products: Oxides of carbon and various hydrocarbons.

Fire Fighting Procedures: As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear.

Unusual Fire and Explosion Hazards: Not expected to be a fire or explosion hazard.

SECTION 6 - ACCIDENTAL RELEASE and DISPOSAL MEASURES

Spills: Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Dilute with water and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container. If necessary: Neutralize the residue with a dilute solution of sodium carbonate.

Large Spills: Dike spill area to contain liquid. Salvage as much re-useable liquid as possible into a suitable container. Absorb with an inert material and put the spilled material in an appropriate waste disposal. Neutralize the residue with a dilute solution of sodium carbonate.

SECTION 7 - STORAGE AND HANDLING

Handling: Keep container dry. Do not ingest. Do not breathe gas/fumes/ vapor/spray. Never add water to this product. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, alkalis, moisture.

Storage: Keep container tightly closed. Keep container in a cool, well-ventilated area.
