### SECTION 4 - FIRST AID MEASURES

**Eyes:** Flush with running water for several minutes. Seek medical attention if irritation persists.

**Skin:** Wash exposed skin with soap and water. Seek medical attention if irritation persists.

**Inhalation:** For excessive inhalation remove to fresh air. If not breathing, give artificial respiration. Seek medical attention.

**Ingestion:** DO NOT induce vomiting. Rinse mouth with water. Seek medical attention.

### SECTION 5 - FIRE FIGHTING MEASURES

**Extinguishing Media:** To extinguish flames use water spray, dry chemical, carbon dioxide or fire fighting foam. .

**Fire Fighting Procedures:** Cool exposed containers with water spray. Wear self-contained breathing apparatus (SCBA) operated in pressure demand mode and full bunker firefighter's protective clothing.

**Fire and Explosion Hazards:** Containers can rupture and explode under fire conditions due to pressure and vapor buildup. Heated vapors may form explosive mixture with air. Vapors may travel across the ground and reach an ignition source.

### SECTION 6 - ACCIDENTAL RELEASE and DISPOSAL MEASURES

Ventilate the area and stop source of spill. Salvage and recycle as much material as possible. Eliminate sources of ignition. For small spills, use absorbent material such as towels or absorbent powders. Put all material into proper waste disposal container with lid tightly covered.

For larger spills, contain spill, recover free liquid, collect with an electrically protected vacuum cleaner or by wet-brushing, and use absorbent material to dry area and then rinse area with water. Put all material into appropriate waste containers. Avoid contaminating ground and surface water.

### SECTION 7 - STORAGE AND HANDLING

**Handling:** Wash thoroughly after handling. Remove contaminated clothing. Ground and bond containers when transferring material. Use spark-proof tools and explosion proof equipment. Avoid contact with eyes, skin, and clothing. Empty containers retain product residue, (liquid and/or vapor), and can be dangerous. Keep container tightly closed. Keep away from heat, sparks and flame. Avoid ingestion and inhalation. Use with adequate ventilation. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose empty containers to heat, sparks or open flames.

**Storage:** Keep away from sources of ignition. Store in a tightly closed container. Keep from contact with oxidizing materials. Store in a cool, dry, well-ventilated area away from incompatible substances. Flammables-area.

### SECTION 8 - EXPOSURE CONTROLS AND PERSONAL PROTECTION

**Engineering Controls:** Use explosion-proof ventilation equipment. Provide ventilation or other engineering controls to keep the airborne concentrations of vapor or mists below the applicable workplace exposure limits indicated below. The level of protection and types of controls will vary depending upon potential exposure conditions.

**Exposure Limits:** Propyl Acetate 200 ppm ACGIH 200 ppm OSHA

#### Personal Protective Equipment (PPE):

**Eyes:** Wear appropriate protective eyeglasses or chemical safety goggles as described by OSHA's eye and face protection regulations in 29 CFR 1910.133.

**Skin:** If prolonged or repeated skin contact is likely, wear appropriate protective gloves.

**Clothing:** Selection of protective clothing depends on work conditions.

**Respirators:** Where adequate ventilation is not available an approved respirator must be worn. Respirator selection, use and maintenance should be in accordance with the requirements of OSHA Respiratory Protection Standard, 29 CFR 1920.134. In confined areas, use a self-contained breathing apparatus.

**Other Equipment:** Adequate explosion proof ventilation to control airborne concentrations below the exposure limits. Eye wash station and drenching shower in close proximity to use are advised.
